Price Structure and How Price is Determined	Fixed Price: Our agreement with you (referred to as our "Agreement") is for an all-inclusive per kilowatt-hour (kWh) price that will remain the same for the term of the Agreement.
Generation/Supply Price	<b>\$0.0790/kWh</b> for generation services. Price excludes taxes, utility transmission and distribution service charges, and other non-bypassable utility charges and fees. Base monthly fee: \$0. Please note transmission charges are included for Duke Energy customers.
Process Customer May Use to Rescind the Agreement Without Penalty	Under PUCO rules, you have seven calendar days following the postmark date on the utility's enrollment confirmation notice to rescind (cancel) the agreement either by (1) calling the utility at the toll-free number provided in the notice, or (2) providing written notice to the utility to the address provided in the notice. You will be able to rescind the decision to select Rushmore Energy as your electric energy supplier, without penalty, if notice is given within the rescission period.
Contract Term/Length	24 monthly billing cycles. Your service will start on a meter-read date set by your Electric Distribution Utility (EDU).
Early Cancellation Fees	Yes. If you cancel your contract early, we may charge you a cancellation fee of \$5 for each month remaining in the term.
Late Payments/Collections	Payment arrangements and late fees will be handled through your utility. However, Rushmore Energy retains the right to collect any and all fees or charges, including reasonable attorney fees and court costs, incurred in connection with the collection of delinquent balances, including early cancellation fees.
Renewal Terms	Our Agreement may be automatically renewed <b>with</b> advance written notices sent separately between 45 and 90 days before the expiration of our Agreement. If you do not respond to these notices we can automatically place you into a month-to-month product, but you will be able to cancel the automatic renewal without any early cancellation fees.
